

SECTION 1 - THE SCHEDULE BLANKET PURCHASE AGREEMENT (BPA) No. TBD

ESTABLISHED BETWEEN US Consulate General in Jeddah, Saudi Arabia AND THE BPA HOLDER:

I. SCOPE OF SERVICES

The contractor shall provide Trash Collection Services for the U.S. Consulate General Jeddah, Saudi Arabia. The contractor shall complete all work, including furnishing all labor, material, equipment, and services, unless otherwise specified herein, required under this contract for stated services within the time specified herein. In consideration of satisfactory performance of all scheduled services required under this agreement, the contractor shall be paid a firm fixed-price for all services.

II. TYPE OF AGREEMENT

This is a Blanket Purchase Agreement with fixed service charges. The fixed price listed below shall include all labor, materials, overhead, and profit. This agreement shall not obligate any funds. Hence the US Consulate Jeddah is **not** obligated to purchase any definite amount under this agreement. The funds obligation shall occur at the time BPA Calls are placed.

III. PERIOD

The BPA (Blanket Purchase Agreement) will be for three years.

IV. ORDERING PROCEDURES

Services shall be ordered and billed through monthly BPA Calls that shall specify the descriptions, quantities and prices. The funds obligation shall occur at the time BPA Calls are placed.

V. VALUE ADDED TAX

Value Added Tax (VAT) is not included in the CLIN rates. Instead, it will be priced as a separate Line Item in the contract and on Invoices. Local law dictates the portion of the contract price that is subject to VAT; this percentage is multiplied only against that portion.

VI. Prices

In consideration of satisfactory performance of the services required under this BPA, the contractor shall be paid a firm fixed-price (FFP) per month in SAR (Saudi Arabian Riyals). The firm fixed-prices are in SAR (Saudi Arabian Riyals) OR USD (United States Dollar).

Work Performance Includes:

- 1. Contractor shall attend a site survey for the designated trash room at US Consulate Jeddah on November 20, 2022 at 10:00 am.
- 2. Contractor shall take all required measurements and recommend the number of required dumpsters fit the designated trash room and enough produced trash.
- 3. The Contractor shall provide a high-quality trash pins which must have a sealed sliding cover with wheels.
- 4. Contractor shall send the truck to collect all the trash from the designated trash room once a day or as required and requested by the COR.
- 5. Contractor shall be responsible for cleaning and hygienic the trash pins daily.
- 6. Contractor shall provide all supervision, labor, materials, tools, equipment, and PPE.
- 7. With no cost, the Contractor shall be responsible for repair / replace any broken trash pin/dumpster.
- 8. The Contractor shall be responsible for any damage / break might be happened to the system or property during the service.
- 9. Contractor shall follow all health and safety issues related to the job and as directed by the Post Safety Officer.


